What is a solar power purchase agreement (PPA)?

A solar power purchase agreement (PPA) is a financial contract in which a third-party developer owns, operates, and maintains the photovoltaic system, and a customer agrees to purchase the system's electric output from the solar services provider for an agreed-upon price and for a predetermined period.

What is a MW in energy storage?

In the context of energy storage, a MW is used to describe the amount of power that a project can either charge or discharge at any given moment in time, oftentimes referred to as the nameplate capacity in the context of conventional generation.

Do you need an EPC contract for energy storage projects?

When developing an energy storage project, a project owner can either engage an EPC contractor to provide a fully-wrapped EPC agreement that will encompass the procurement, installation, and commissioning of batteries. In many cases, however, owners will contract directly with battery suppliers for battery supply and commissioning.
