What is energy storage PPA?

There are mixed approaches to setting the term for energy storage PPAs. Some forms of energy storage are considered to have a longer useful life than the related generating source. In a battery system, for example, individual batteries can often simply be replaced and the unit will carry on.

Should energy storage units be regulated under the Federal Power Act?

The PPA will need to be clear regarding the rights to each product and service if a single offtaker will not be entitled to all of the multiple revenue streams. To date, there is a lack of clear precedent about how energy storage units are to be regulated under the Federal Power Act.

What is grid charging?

Grid Charging: "Grid charging" refers to the charging of the energy storage system from energy on the power grid (as opposed to a paired energy generation resource, such as wind or solar).

Does a power contract cover energy storage?

There are several energy storage models, each requiring different approaches to product definitions and performance parameters. The most prevalent model appears to be storage combined with a solar project, where the two are treated as a single system. Therefore, the power contract covers both. There is a natural synergy.

Storage Capacity: All rights and products and attributes associated with the maximum dependable operating capability of the Storage Facility to be charged with, store and discharge electric energy. ...

Accordingly, the size of an energy storage facility should typically include both a reference to its power rating (MW) and energy storage capacity (MWh), such as a 100 MW/400 MWh facility.

The capacity of battery storage systems is expressed in both power (kW) and energy (kWh) terms. System costs may also be expressed in power, energy, or a hybrid manner.
